Shipping Policy

All orders are processed within 2-3 business days. Orders are not shipped or delivered on weekends or holidays. If we are experiencing a high volume of orders, shipments may be delayed by a few days. Please allow additional days in transit for delivery. If there will be a significant delay in the shipment of your order, we will contact you via email or telephone.

Shipping Rates & Delivery Estimates

Shipping charges for your order will be calculated and displayed at checkout. Delivery delays can occasionally occur.

Damages

Üforia is not liable for any products damaged or lost during shipping. If you received your order damaged, please contact the shipment carrier to file a claim.

Please save all packaging materials and damaged goods before filing a claim.

Customer Refund Policy

If within thirty (30) days of purchasing Üforia product a Customer is not satisfied with the product for any reason, the Customer may contact support@uforiascience.com to return the unused portion of the product for a full refund of the product purchase amount, minus shipping and handling charges incurred. For Ütrition and Prime, a restocking fee equal to 30% of the original price of the product will be applied.

After thirty (30) days and up to ninety (90) days post purchase, you must contact support@uforiascience.com to return the remaining resalable portion of the product for a full refund minus a 30% percent processing fee of the original price for all returned product.

Lab fees, used (swabbed) DNA kits, reports and/or any other electronically delivered products, and special items such as trainings, certifications or event tickets are non-refundable.

Any shipping and handling charges incurred when shipping and/or returning the product will not be refunded. Additionally, anytime an order is refunded, all commissions paid on returned product will be deducted.

Ütritionist™ Refund Policy

If within the first thirty (30) days of original purchase, you are not satisfied with the product you must contact support@uforiascience.com to return the unused portion of the product for a full refund of the product purchase amount, minus shipping and handling charges incurred. For Ütrition and Prime, a restocking fee equal to 30% of the original price of the product will be applied. Your Ütritionist account may be subject to six (6) months suspension.

After thirty (30) days and up to ninety (90) days post purchase, you must contact support@uforiascience.com to return the resalable portion of the product for a full refund minus a 30% percent processing fee of the original price for all returned product. Any shipping and handling charges incurred when shipping and/or returning the product will not be refunded.

Return Process

All returns, whether by a Customer or Ütritionst™ must be made as follows:

- Obtain a Return Merchandise Authorization ("RMA") number from Üforia by contacting support@uforiascience.com and submitting a request for the RMA.
- Ship items to the address provided by Üforia customer service when you receive your RMA.
- Provide a copy of the sales receipt or invoice with the returned product. Such invoice must reference the RMA and include the reason for the return.
- Ship product back in the original manufacturer's box exactly as it was delivered.
- All returns must be shipped to Üforia pre-paid, as Üforia does not accept shipping collect packages. Üforia recommends shipping returned product by UPS or FedEx which includes tracking information and insurance, as risk of loss or damage in the shipping process of the returned product shall be borne solely by the Customer or Ütritionist. If returned product is not received at the address provided on the RMA, it is the responsibility of the Customer or Ütritionist to trace the shipment of the product wherein no credit will be applied.
- Returning \$500 or more of Üforia product accompanied by a request for a refund within one (1) calendar year by a Ütritionist, may constitute grounds for involuntary termination of the Ütritionist's Account.

SmartSave (a.k.a. Auto-Ship) Cancellation

Please email support to cancel or modify your auto-ship at any time at support@uforiascience.com, without penalty. You can also modify or cancel your order at any time by logging into your account at www.uforiascience.com. By selecting the "SmartSave Subscription Order" option, under the "Subscriptions" menu on the website, you are giving Üforia authorization to enroll you in the automatic shipping program. Üforia will ship your products directly to you. You are also authorizing Üforia to charge your credit card for the products you have ordered on a monthly basis.
